- viii) Experience claimed is required to be supported by documentary evidence such as newspaper/magazines clippings of each year of relevant experience during the last 3 years.

- ix) In support of the circulation claim of the newspaper/periodicals, please furnish copy of RNI/ABC circulation certificate.
- x) Directors, Producers etc. of films, TV programmes etc. are not eligible for special accreditation.
- xi) A newspaper or group of newspapers with the same title will be eligible for 1(one) accreditation for up to circulation of 75,000 copies and 2(two) for circulation more than 75,000.
- xii) Electronic media organization will be eligible for accreditation of one team consisting of one correspondent, one cameraman and one technician subject to completion of formalities.
- xiii) Foreign journalist must have 'J' Visa to qualify.
